Haulers contracted by The H&K Group (and its affiliated companies) will receive the added benefit of having their fuel invoices automatically deducted from any balance they are owed, lessening out-of-pocket expenses. If a division of The H&K Group does not owe anything to your company, payments are due on or before the 15th and 30th of each month for the fuel consumed the prior period.

The diesel rate will be based on the current market price and published daily at www.AmericanFuelsPA.com/Fleet. For all purchases, a daily invoice will be mailed out to account holders detailing any transactions that occurred.

NOTE: If a division of The H&K Group does not owe anything to your company payments are due on or before the 15th and 30th of each month for the fuel consumed the prior period. Returned check fee is \$70. A service charge of 1.5% will be incurred on any outstanding account balances every 1st and 16th days of each month after date of delivery.
